4. Modernization of spill channel from RD 1280M to 1338.5M USHP-II, Kangan.


For Prequalification Criteria reflected under Cover- I Pre-qualification Documents item 1 on Page No. 12 of Tender Documents of above works, please read **last Ten years** instead of **last Seven years**.

In addition, the condition reflected at item No. 7 in the tender documents of the above noted works on page No.16 under clause 'FOR SPECIAL ATTENTION OF THE TENDERER' quote- "**The tenderer if found successful for more than one work shall have to full fill proportionately combined pre- qualification criteria for the work in question or he may choose to select any one of his works in which he works out successful**" unquote, are modified as under:-

'The tenderer who intends to bid for more than one work will be required to full fill proportionately the combined pre-qualification criteria as per Cover- I for the total cumulative cost of all those works put together and such tenderers shall have to submit the list of all works in Cover-I in which he is bidding among these works in order to finalize his pre-qualification in more than one work. Price Bids shall be opened only for one work if tenderer has tendered for one work only, if he gets qualified, or for more than one work if he gets qualified for those works cumulatively as per above criteria'.

The date of receipt of tenders of the works in question is extended up to 10th December 2011 by 1500 hours and the tender documents will be issued or down loaded now from JKSPDC'S web site www.jksodc.nic.in by or before 07-12-2011.

All other terms and conditions will remain same as laid down in the aforementioned NIT.
