1. Name & Scope of Work : Supply & Installation of Runners (Pelton Type) 4 Nos for Turbine units of CHEP Stage-I , 4.66 MW +/- 10% rated capacity to replace the existing runners (pelton Type) .

3. The tenders should reach the office of the Chief Engineer, Generation Wing PDC, Lane No. 3, H.No. 310, Adarsh Colony, Sector-I, Ext. Trikuta Nagar, Jammu on or before 11.08.2011 upto 2 pm and shall be opened on the same day or any other date convenient to the Chief Engineer, Generation Wing , PDC Jammu in presence of Contractors / representatives of the Contractors / Firms who may like to be present.
4. Bidding Documents are non transferable and can be obtained by interested firms or their authorized representatives in person or by Post on submission of a written application on proper letter head along with copy of registration certificate and on payment of non-refundable specified amount. Issuance of the bidding documents, however, shall not automatically mean that such firm fulfills / meets the Qualifying Requirements. The Bidders desirous of obtaining the tender documents by post shall enclose an additional Demand Draft for Rs. 1000.00 in favour of "Chief Pay and Accounts Officer, Unit 1st JKSPDC Jammu payable at Jammu as packaging and postage charges.
5. The tenderer should satisfy the following conditions:-
 - a) Should be fully equipped to carry out works with proven expertise of more than Five years (prior to opening date of bid :

- in execution of such works .
- b) Should be EPF / TIN No. holder.
 - c) Should provide name , detail and profile of the firm its complete address and the name of the contact person along with contact no. and E-mail address .
 - d) Should provide the details/list of infrastructure the company has.
 - e) Should be able to provide & replace existing Pelton wheel runners fully compatible to existing system & in conformity to the relevant IS / IEC standards.
 - f) Should fulfil other eligibility conditions as detailed in the Tender Document.

The Tenders should be accompanied with a CDR for an amount equal to 2% of the quoted value, pledged to the Chief Pay & Accounts Officer Unit 1st , JKSPDC Jammu or the bid security shall be denominated in Indian Rupees favouring Chief Engineer, Generation Wing Jammu JKSPDC, Home No. 310, Lane No. 3, Adarsh Enclave, Trikuta Nagar, Jammu and shall be in the following form:
