**SHORT TENDER NOTICE**



Based upon the requirement and the performance the addition in number of vehicles can be increased/ decreased based upon the requirement.

**Instructions for the intending tenders.**

1. The tenders should reach in the office of the Executive Engineer Civil Maintenance Division BHEP-I, Chanderkote on or before 27.09.2011 upto 2.00PM through registered/speed post/by hand and shall be opened on the same day or any other subsequent date convenient to opening authority in presence of such tenderer who may choose to be present at the time of opening of tenders.
2. The tender can be submitted in the format given below along with the photo copies of the relevant documents mentioned in the format.
3. The tenders received after expiry of time and date shall not be entertained.
4. In case the fixed date for receipt of tenders is declared a holiday, the date of receipt of tenders shall be reckoned as the next working day.
5. Conditional tenders will be rejected.
6. The Executive Engineer Civil maintenance Division BHEP-I, Chanderkote reserves right to accept or reject any tender or tenders without assigning any reason thereof.
7. The tender should be accompanied with Earnest money in the form of CDR for an amount equivalent to advertised on any schedule bank pledged to Executive Engineer Civil Maintenance Division BHEP-I, Chanderkote.
8. The earnest money will be released to the un-successful tenderer only after allotment.
9. In case of successful tenderer, CDR will be released after successful completion of the period.
10. The tender received without CDR shall not be entertained.
12. The date of deployment of vehicle along with Driver shall be within 7 days from the date of issue of allotment order.
13. Rates quoted shall be valid for one year from the date of actual hiring of vehicle.
14. The offer should be valid for 30 days from the date of opening of the tender.
15. Vehicles used for the work must be pollution free with valid pollution free certificate.


