In case the last date of receipt of tenders happens to be a holiday or otherwise tenders shall be received on next working day. The tender document for the above mentioned works covering the terms & conditions of the contract can be had from the office of the U/sd. after production of valid enlistment card/Tin/Pan Nos. as well on any working day during office hours 12/12 to 14/12/11 3P:M on cash payment (non-refundable)
- The enlistment card should be renewed for the financial year 2011-12.
- The work shall have to be executed in accordance with the specifications that may be laid down by the Executive Engineer, I/C of the works within the time limit specified for such works failing which the penalty of (Ten Percent) 10% of the total cost of work shall be imposed upon the contractor for one week, and beyond one week penalty of Rs:- 1000/=per day will be imposed which shall be at the discretion of the competent authority based on the valid grounds. The under signed reserves to himself the right of granting an extension in the time limit .In case the work is not still completed within the period of the time so extended , Contractors security deposit shall be confiscated in addition to in position of 10% penalty as per agreement.
- The contractor shall have to quote rates separately in respect of such items which are outside SSR and for which rate has been asked for. In case the tenderer fails to quote rate for such item, the same item shall be got executed by the contractor free of cost/lowest quoted rate when the highest rate shall be applicable to work out the comparative cost .
- Only those contractors can cast their tender who is registered with sales tax department. The tender document shall be issued to the intending contractors only

08. Rebated / free of cost tenders shall not be entertained and the same shall be rejected out-rightly by the tender opening authority

10. The payment on a/c of work done shall be made as and when the funds are available for the same.
