



**Sub: Regularization of services of Steno-Typists of JKSPDC.**

**ORDER NO.PDC/ 199 of 2017**

Whereas, pursuant to the decision taken by the Board of Directors in its 65<sup>th</sup> meeting, 25 posts of Steno-Typist were advertised vide notification No. JKSPDCL/ADM/4342 dated 25.08.2012.

Whereas, after a rigorous process of selection, the candidates were selected vide Notification No. JKSPDC/ADM/EG-258/36 dated 25.05.2015 & subsequently appointed vide Order No. PDC/25 of 2015 dated 15.06.2015 on contractual basis and were to be regularized after completion of two years satisfactory contractual service as per policy adopted by the JKSPDC.

Whereas, 16 candidates were provisionally selected and directed to attend the Corporate Office, JKSPDC, out of which only 13 candidates joined the Corporate Office, JKSPDC vide order No. JKSPDC/25 of 2015 dated 15.06.2015, on contractual basis for a period of two years.

Whereas, 2 candidates did not report for duties after their appointment in the JKSPDC out of the said lot.

Whereas, the In-House Committee met on 16.08.2017 and recommended the regularization of 11 Steno-Typists who have completed two years services on the same analogy, terms and conditions adopted for other earlier batches of Junior Engineers and Finance Assistants as per policy circulated vide No. JKSPDC/ADM/EG-214/4262-4379 dated 16.12.2011.

Now, therefore, in view of the completion of two years satisfactory contractual services and recommendations of the In-House Committee, sanction is hereby accorded to the regularisation of the services of following Steno-Typists in the pay scale of Rs.5200-20200 with GP Rs.2400/- from the dates as shown against each hereunder:-

Regularisation of the above Steno-Typists shall be subject to the following conditions: -

- i. The Steno-Typists shall be regularised in the pay Band of Rs.5200-20200 with GP Rs.2400/-
- ii. The regularisation order shall have effect from the date of competition of two year's contractual service. However, two years contractual service period shall count for their seniority purpose only which shall be fixed in accordance with the merit position assigned in their first engagement order on contractual basis.
- iii. The service of these Steno-Typists shall be governed by the Policy, Rules and Regulations whatsoever adopted by JKSPDC.
- iv. The entitlement of leave, allowance and perks shall as per the procedure/practice, presently in vogue for such categories of employees borne on the cadre of JKSPDC.
