This is for your information that an e-mail was received from e-mail ID ashaqelahi@gmail.com on e-mail ID of the Company Secretary posted in Corporate Office, JKSPDC i.e. (guptasunil808@gmail.com) on 28.05.2021 at 10:02 A.M., wherein, the following was mentioned (copy enclosed):

“My name is Ashaq Ahmad Chund, I had applied for direct recruitment JKSPDC as Sr. Office Assistant through Ministry of Power, New Delhi. My joining date is 1st June, 2021, but Ministry of Power told me that you have to submit affidavit of Rs. 2000 Stamp Paper from High Court as I had already submitted 5 affidavits from High Court and I have spent above Rs. 15000/- for this job due to lockdown I don't have money to submit affidavit worth Rs. 2000/- as I belong to a very poor family. It's my humble request to you to kindly help me regarding this matter.”

Importantly, an information is also received telephonically today i.e. 28.05.2021, from T.O. to the Chief Engineer, CI&D Wing, Kashmir, JKSPDC that a person named Mr. Ashaq Ahmad Chund visited their office with an fictitious Job offer letter for joining there as Senior Office Assistant. The copy of the fictitious Job offer letter issued by forging the signature of Sh. Sunil Gupta, Company Secretary, Jammu and Kashmir State Power Development Corporation Limited is enclosed.

The officer (Company Secretary) has immediately approached the undersigned with the declaration that no such order was issued by him and he requested that immediate appropriate action be taken for investigation and action against the fraudster. More importantly, neither such recruitment process was initiated by the Corporation nor any appointment was made by the Corporation in past or present nor Sh. Sunil Gupta,



Company Secretary, JKSPDC, has been authorised to issue such appointment letter.


It is a clear cut case of forgery, cheating and defrauding the organisations (JKSPDC) in order to get wrongful gains. It has also been done with the intention to malign and defame the reputation of the Officer in specific and the Organisation in general, and the same, immediately needs to be addressed.

It is pertinent to mention that recently vide letter No. JKSPDC/7228-35 dated 23.02.2021, a similar case of forgery was reported by the undersigned to your good office (copy enclosed). However, no action seems to have been taken.

It is as such requested to file an F.I.R. for investigation and action against the fraudster immediately so that such instances are not repeated.


