With reference to eNIT no. 01 of DE of 2020-21 dt 21.11.2020 regarding " Comprehensive Annual maintenance Contract of Hardware/software , support of servers and other allied IT/non IT equipments including deputation of one onsite resource person at Data Centre , Corporate Office JKPDC , Jammu " and Pre bid meeting held on 04-Dec-2020, please refer following corrections/clarifications:

1. **Rs. 0.55 Lacs** in the form of Demand Draft in favour of General Manager(Accounts), JKPDC, Jammu payable at Jammu. Scan copies of DD's shall be attached with the e-technical bid:
In this regard, in continuation to the existing clause, please read "Exemption as per guidelines for MSEs (Micro & Small Enterprises) by the Central Government .Certificate in this regard to be submitted along with bid submission."
2. Please read S.no. of UPS 10 KVA online as **IQ0743008624** instead of IQ0793008624.
3. Refer item 17 of Table A .*It is clarified that it involves the upgradation/ replacement of existing Windows 2008 server softwares installed in servers with compatible Microsoft Windows 2019 standard server softwares which are to be installed along with device drivers and support/AMC in the existing servers as specified in Table A(OEM items). However if required the CAMC firm should be able to downgrade it accordingly to make it compatible with existing servers (at no extra cost) and shall be read accordingly in the Bid documents.*
4. As discussed in pre bid, JKPDC may intimate the OEM(Bluestar) to provide AMC of Bluestar Precision AC to the firms approaching OEM, if required. Also, one of the bidders approached JKPDC for consent letter to ZNet . Letters to Bluestar and ZNet are uploaded on JKPDC website (www.jkspdc.nic.in) for reference of prospective bidders.
5. At page -15 clause 12: Billing and payments: if any item is deleted within the duration of the contract period, the payment of the same shall be adjusted on the prorata basis till the services of that item are utilized.
In response to one of the prebid query, it is to be interpreted as that this clause shall not be applicable to those OEM items where yearly charges as paid in advance to OEM subject to authentication of payment made by vendor to OEM in advance. For other items /non OEM , the bid provision shall prevail and JKPDC (the owner) shall be at discretion to delete any of these items .
