The entire bidding process shall be online; the online bids must be submitted in two separate covers. Cover one distinctly marked as "COVER-I" shall contain techno commercial bid, EMD in original and Cost of tender document in the form of Bank Draft. Cover-II distinctly marked as "COVER-II" shall contain price bid only. Tenders/Bids complete in all respects must be accompanied with cost of tender documents in shape of demand draft in favour of "Executive Engineer ECD Karnah" (tender inviting authority) and Earnest money/Bid security in shape of CDR pledged to "Chief Engineer Generation Wing Kashmir" (tender receiving authority). The hard copy of the tenders complete in all respects should reach to the office of the Chief Engineer Generation Wing Kashmir on or before the date mentioned above in sealed envelopes through registered post or by hand. The online bids of the agencies who do not submit the hard copies by or before the receiving date shall not be opened and will be rejected without assigning any reason.

Terms and Condition:

1. Bidders must ensure to upload scanned copy of all necessary documents with the bid including the Original/photocopies of documents related to the bid to be submitted physically/by registered post/courier after online opening of the tender.

2. *All the Scanned documents should be on PDF format with Black & White option only.*
3. *The department will not be responsible for delay in online submission due to any reason.*
4. *The scanned copy of the Demand Draft and Earnest money in shape of CDR must be uploaded with the documents of bid. The original Demand Draft (Cost of tender document), CDR (Earnest money/Bid security) and relevant bid documents shall be submitted in the office of the Chief Engineer Generation Wing Kashmir Bemina Srinagar by registered post/courier or by hand before due date of submission of tender as per time schedule specified.*
5. *Bidders are advised not to make any change in BoQ (Bill of Quantities) contents. In no case they should attempt to make similar BoQ manually.*
6. *The unit rates and prices shall be quoted by the bidder entirely in Indian rupees and the rates quoted shall be deemed to include price escalation and all taxes (GST) up to completion of job unless otherwise specified. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill as per the rates prevailing at the time of payment. No escalation is payable in respect of the instant contract.*
7. *The contractor shall have to make his own arrangements for the safety of labour, Machinery & material during execution of the work. Providing of warning signals & other related arrangements whatever and where ever required/needed shall be the entire responsibility of the contractor.*
8. *90% payments shall be released only after proper verification of the bill and performance report of AEE concerned and remaining 10% shall be released after successful Completion of DLP of one Year from the date of commissioning of the Job.*
9. *All other terms and conditions as laid down in Short Term Quotation concerned, PWD form 25(D) as applicable for such kind of jobs shall remain in force.*
